

# MyEO DX24 Angel-Shark Experience Official Contest Rules

## **NO PURCHASE NECESSARY:**

No purchase is necessary to enter.

#### **ELIGIBILITY REQUIREMENTS:**

The MyEO DX24 Angel-Shark Experience Contest is open only to those who sign up at the [Shark Experience Application MyEO DX24 URL] and who are EO Members as of the date of entry. The MyEO DX24 Angel-Shark Experience Contest is only open to registered attendees of the MyEO DealExchange DX24 Conference being held in Austin, Texas, on 11-14 September 2024. All information required on the online form must, subject to disqualification, be completed and truthful and an Executive Summary must be provided.

#### **CONTEST PERIOD:**

Entries will be accepted using the online form starting on 1 December 2023, 8:00 A.M. PDT and ending 5 September 2024, 11:59 P.M. PDT. All entries must be received by September 5 2024, 11:59 P.M. PDT.

#### **HOW TO ENTER:**

The MyEO DX24 Angel-Shark Experience Contest must be entered by submitting an entry using the online form provided at [https://forms.gle/Wm8m6T72egE8Gf4u8]. The entry must fulfill all MyEO DX24 Angel-Shark Experience Contest requirements, as specified, to be eligible. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of the MyEO DealExchange Executive Team.

## **SELECTION CRITERIA:**

Up to 20 Contestants will be selected to participate in the MyEO DealExchange Angel-Shark Experience and have the opportunity to provide their pitch before the MyEO DX24 panel of Angel-Sharks. Contestants will be selected by the MyEO DealExchange Executive Team and presented to the MyEO DX24 panel of Angel-Shark-Angels. The MyEO DX24 panel of Angel-Sharks will review the contestants and make a final selection of 20 finalists. The final Contestants will be notified by email within 2 of days following the MyEO DX24 Angel-Sharks' final selections. The final Contestants will be determined by the following criteria:

- Business viability
- Team
- Pitch Quality

#### THE PITCH:

20 Final Contestants will provide their pitches in front of the MyEO DX24 panel of Angel-Sharks on 12 and 13 September 2024. Contestants will have no more than 3 minutes to deliver their pitch which must include their name, location, background, business mission, product or services, target market, and progress status. The panel of Angel-Sharks will invest at least \$250,00 between up to 5 contestants (so long as the investors determine the deals are viable options for their priorities). No funds will be distributed at this event. All offers made are subject to the individual closing requirements of each Angel.
